CITY OF WHITE, GEORGIA ORDINANCE AMENDMENT

AN ORDINANCE OF THE CITY OF WHITE TO AMEND CHAPTER 3, TITLE 8, SECTION 8.2.9, OF THE OFFICIAL CODE OF ORDINANCES OF THE CITY OF WHITE, GEORGIA, REGULATING TRUCK TRAFFIC AS ADOPTED NOVEMBER 6, 2000, AND AS THEREAFTER AMENDED; AND FOR OTHER PURPOSES.

WHEREAS, the Mayor and Council deem it necessary to amend the City of White Truck Ordinance; and

WHEREAS, thru truck traffic has increased; and

WHEREAS, the unnecessary destruction of our streets by overloaded trucks desiring to avoid state routes; and

WHEREAS, the major expense of repairing and resurfacing streets is placing a strain on the City's Budget; and

WHEREAS, trucks crossing the high railroad crossing on Richards Road are causing hazardous conditions for the public; and

WHEREAS, the need for signs controlling truck traffic has become necessary.

NOW, THEREFORE BE IT ORDAINED AND IT IS HEREBY ORDAINED AS FOLLOWS:

Section 8.2.9 TRUCK TRAFFIC.

(a) Definitions. For the purpose of this section, the following words and terms shall have the meanings respectively ascribed:

Local traffic shall mean any truck deliveries to or from any lot, location, residence or business place within the city

Sign shall mean the notice "No through Trucks" or "No Trucks Allowed" posted at each entrance point to the prohibited area.

Trucks shall mean any van, van-style, dump body, tractor trailer or tractor only or any truck together with a trailer when the truck or truck and trailer contain more than six wheels touching the roadway at any one time or any vehicle exceeding 10,000 pounds in weight.

(b) Offense. Except for local traffic it shall be unlawful for any person, firm or corporation to permit, allow, drive or traverse the prohibited area of the city with any truck.

(c) Trucks Prohibited. The following streets, or portions thereof, are hereby designated as prohibited streets for truck traffic:

ROCKY STREET running in a generally east-west direction and beginning at the intersection of West Rocky Street and Old Tennessee Highway (which intersection is located in the City of White) and extending across the intersection with State Highway 411 approximately 1 mile along East Rocky Street to the end of street.

JOHN HUSKINS STREET running in a generally east-west direction and beginning at the intersection of John Huskins Street and State Highway 411 (which intersection is located in the City of White) and extending 1/10 mile along John Huskins Street to the intersection of the John Huskins Street and School Street.

LITTLE STREET running in a generally north-south direction and beginning at the intersection of Little Street and Whispering Pine Lane (which intersection is located in the City of White) and extending 1/10 mile along Little Street to the end of the street.

RAILROAD STREET running in a generally north-south direction and beginning at the intersection of Railroad Street and West Rocky Street (which intersection is located in the City of White) and extending 1/10 mile along Railroad Street to the intersection of Railroad Street and Old Tennessee Hwy.

RICHARDS ROAD running in a generally east-west direction and beginning at the intersection of Richards Road and State Highway 411 (which intersection is located in the City of White) and extending 4/10 mile along Richards Road to the intersection of Richards Road and Old Tennessee Hwy.

SCHOOL STREET running in a generally north-south direction and beginning at the intersection of School Street and West Rocky Street (which intersection is located in the City of White) and extending 3/10 mile along School Street to the intersection of the School Street and Richards Road.

WHISPERING PINE CIRCLE running in a generally east-west/north-south direction and beginning at the southern intersection of Whispering Pine Circle and Whispering Pine Lane (which intersection is located in the City of White) and extending 2/10 mile along Whispering Pine Circle to the north intersection of Whispering Pine Circle and Whispering Pine lane.

WHISPERING PINE LANE running in a generally east-west/north-south direction and beginning at the intersection of Whispering Pine Lane and State Highway 411 (which is located in the City of White) and extending 2/10 mile along Whispering Pine Lane to the end of the street.

(d) PENALTY. The penalty for violations of this section shall be a fine in an amount not to exceed \$1,000.00.

(e) REPEALER. All ordinances or parts of ordinances in conflict herewith are expressly repealed.
