City Council Meeting  
May 3<sup>rd</sup>, 2021

Present at the meeting were Councilmembers Dennis Huskins, Ryan Evans, Charles Buttrum, Curtis Powell, and City Clerk Breanna Bellamy.

The meeting was called to order by Councilmember Evans. Councilmember Dennis Huskins opened the meeting with an invocation. Councilmember Evans Lead the Room in the saying of the Pledge.
